VASA Fitness agrees to provide temporary, short-term KidCare services for the children of our members while those members are present at our fitness facilities. KidCare visits are limited to a maximum of 90 minutes/visit & no more than 2 visits/day (each visit must be paid for), available during posted hours. In exchange for this service, the member agrees to pay VASA Fitness the current posted KidCare rates, unless that rate has been pre-paid through purchase of a membership plan with KidCare included. By signing this agreement, the member(s) acknowledges and agree(s) that:

- 1. They are the parent or legal guardian of the child (6 weeks -12 years of age).
- 2. The KidCare is only provided while the parents/legal guardians are on-site at VASA Fitness, and parents/legal guardians understand and agree that membership and childcare privileges may be revoked for violations.
- 3. VASA KidCare will not be able to accept sick children.
- 4. Picture ID is required to check in/out children from KidCare.
- 5. Children must be checked in and out by the same person.
- Reservations through <u>www.gympayment.com</u> are required to ensure adequate staffing. Reservations not used or cancelled at least 1 hour prior to the reservation time will subject the member to a cancellation fee of \$2/child/reservation. Cancellations of reservations must be taken care of by the member who made the reservations by logging into <u>www.gympayment.com</u>.
- 7. A late fee will be charged for children left in our care for more than 90 minutes, members who stay longer than their scheduled reservation of members returning after posted hours of operation. The fee structure is \$1/child for the first 15 minutes, and \$2/child for each additional 15 minutes or portion thereof. NO exceptions.
- 8. Member agrees to pay any additional fees incurred either at the facility and/or agrees that the facility may charge the additional fees directly to the member's billing on file.
- 9. Our KidCare strives to provide appropriate videos, books, and play activities in our playrooms; However, VASA Fitness does not assume any liability or responsibility whatsoever for the content of any such video, book, or activity.
- 10. VASA KidCare observes a policy where parents will be contacted and asked to retrieve their child if their childcries consistently for 15 minutes or more.
- 11. KidCare staff will enforce a behavioral guideline for the protection of the children and employees. This guideline coversall instances of biting, pinching, fighting, or other acts that may cause physical or emotional pain to others. We reserve the right to deny further admittance to KidCare at our sole discretion.
- 12. Children should be fed and use the restroom, or have diapers changed, prior to check in. If the child must use the restroom or needs a diaper change, the parent will be paged to assist the child.
- 13. Sorry. No food, gum or candy allowed. Bottles for infants must be prepared by the child's parents.
- 14. Children must wear shoes and/or socks while in KidCare.
- 15. Please leave personal items at home. VASA Fitness is not responsible for lost or damaged items.
- 16. It is the parent's responsibility to keep the KidCare informed of any needed updates to their child's records.
- 17. VASA Fitness will make every effort to accommodate the needs of all children. However, the KidCare is not staffed or equipped to provide special care for anyone requiring individual or specialized care or attention.
- 18. Member agrees and consents that VASA Fitness may use photographs, interviews, videos, and any other media featuring you and/or your children for purposes of advertising, illustration, broadcast, or distribution in any legal manner, and you waive any claim for compensation for such use.
- 19. Emergency Services will be contacted in the event of a medical emergency. You consent that the minor child may receive medical treatment deemed advisable by emergency service personnel, and that you will be responsible for any medical expenses incurred by the minor.
- 20. VASA Fitness reserves the right to refuse service to anyone for any reason and reserves the right to change or modify policies and procedures at any time.

In addition to the above, I also agree to RELEASE, HOLD HARMLESS and INDEMNIFY VASA Fitness and its employees, directors, and managers, individual partners, agents, and shareholder for any claims made by a minor or brought on behalf of a minor.

I have read and agree to abide by the KidCare agreement printed above. I further agree to authorize individuals identified on the Admission Agreement form as persons authorized to pick up my child(ren) in case of emergency.
