



## VASA KidCare Admission Agreement

VASA Fitness agrees to provide temporary, short-term KidCare Services for the children of our Fitness members while those members are present at VASA Fitness. KidCare visits are limited to a maximum of 90 minutes & available during posted hours. Members may not split a 90-minute visit; however, they may pay for up to 2 visits per day per child. In exchange for this service, the member agrees to pay VASA Fitness the current posted KidCare rates. By signing this agreement, the member(s) acknowledge and agree as follows:

1. They are the parent or legal guardian of the child (6 weeks -12 years of age).
2. The KidCare is only provided while the parents/legal guardians are on-site at VASA Fitness. Parents/legal guardians understand and agree that membership and KidCare privileges may be revoked for violations.
3. VASA KidCare will not be able to accept sick children and will retrieve parents to pick up sick children.
4. Photo ID or Photo within VASA KidCare check in software is required to check children in/out from KidCare.
5. Children must be checked in and out by the same person.
6. Reservations through [www.gympayment.com](http://www.gympayment.com) are required to ensure adequate staffing. Reservations will be held for 30 minutes beyond their start time; reservations not used within the beginning 30-minute timeframe or cancelled at least 1 hour prior to the reservation time will subject the member to a cancellation fee of \$2 per child per reservation. Cancellations of reservations must be taken care of by the member who made the reservations by logging into [www.gympayment.com](http://www.gympayment.com).
7. A late fee will be charged for children left in our care for more than 90 minutes, members who stay longer than their scheduled reservation or members returning after posted hours of operation. The fee structure is \$1 per child for the first 15 minutes, and \$2 per child for each additional 15 minutes or portion thereof.
8. Member agrees to pay any additional fees incurred either at the facility and/or agrees that the facility may charge the additional fees directly to the member's billing on file.
9. Our KidCare strives to provide appropriate videos, books, and play activities in our KidCare's; however, VASA Fitness does not assume any liability or responsibility whatsoever for the content of any such video, book, or activity.
10. Parents will be contacted and asked to retrieve their child if their child cries consistently for 15 minutes or more.
11. KidCare staff will enforce a behavioral guideline for the protection of the children and employees. This guideline covers all instances of biting, pinching, fighting, or other acts that may cause physical or emotional pain to others. VASA KidCare will document all behavioral concerns and reserves the right to suspend or deny further admittance to KidCare at our sole discretion.
12. Children should be fed and use the restroom, or have diapers changed, prior to check in. If the child must use the restroom or needs a diaper change, the parent will be contacted to assist the child. Children with soiled clothing will be sent home. Children must be fully clothed with no exposed diapers.
13. No food, gum or candy allowed. Bottles for infants must be prepared by the child's parents & clearly labeled with the child's name.
14. Children must wear socks and/or shoes while in KidCare.
15. Please leave personal items at home. VASA Fitness is not responsible for lost or damaged items. All unclaimed items will be donated to charity on a regular basis.
16. It is the parent's responsibility to keep the KidCare informed of any needed updates to their child's records.
17. VASA Fitness will make every effort to accommodate the needs of all children. However, the KidCare is not staffed or equipped to provide special care for anyone requiring individual or specialized care or attention.
18. Member agrees and consents that VASA Fitness may use photographs, interviews, videos, and any other media featuring you and/or your children for purposes of advertising, illustration, broadcast, or distribution in any legal manner, and you waive any claim for compensation for such use.
19. Emergency Services will be contacted in the event of a medical emergency. You consent that the minor child may receive medical treatment deemed advisable by emergency service personnel, and that you will be responsible for any medical expenses incurred by the minor.
20. VASA Fitness reserves the right to refuse service to anyone for any reason and reserves the right to change or modify policies and procedures at any time.

In addition to the above, I also agree to RELEASE, HOLD HARMLESS and INDEMNIFY VASA Fitness and its employees, directors, and managers, individual partners, agents, and shareholders for any claims made by a minor or brought on behalf of a minor.

I have read and agree to abide by the KidCare agreement printed above. I further agree to authorize individuals identified on the Admission Agreement form as persons authorized to pick up my child(ren) in case of emergency.
