



# KIDCARE ADMISSION AGREEMENT

VASA Fitness agrees to provide temporary, short-term KidCare services for the children of our members while those members are present at our fitness facilities. KidCare visits are limited to a maximum of 90 minutes/visit and no more than 2 visits/day, during posted KidCare hours. In exchange for this service, the member agrees to pay VASA Fitness the current posted KidCare rates at the time of service through automatic billing of the credit/debit card on file. By signing this agreement, the member(s) acknowledges and agree(s) that:

1. They are the parent or legal guardian of the child (2 years -12 years of age).
2. KidCare is only provided while the parents/legal guardians are on-site at VASA Fitness, and parents/legal guardians understand and agree to stay on premise while their children are in KidCare.
3. VASA KidCare will not be able to accept sick children.  
Please keep your children at home if they are experiencing any of the following symptoms: *Fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea.* Our goal is to keep all kids healthy and safe while in our care.
4. Photo ID is required to check children in and out of KidCare.
5. Children must be checked in and out by the same person.
6. Reservations must be made through the VASA app for each child that uses KidCare services to hold their spot and enable time to plan for adequate staff.
7. The cost of KidCare is \$3/child for up to 90 minutes, to be paid at the time of service.
8. If you cancel within 4 hours of your scheduled time, or do not show up to your scheduled KidCare appointment, there will be a \$3 late cancel/no show fee. This fee will be billed to the credit/debit card on file.
9. Late fees will be charged for children picked up after their scheduled appointment. The fee structure is \$3/child for every 15 minutes they remain in KidCare over their scheduled time. These fees will be charged directly to the credit/debit card on file at the time of service.
10. KidCare strives to provide appropriate videos, books, and play activities in our playrooms, however, VASA Fitness does not assume any liability or responsibility for the content of any such video, book, or activity.
11. VASA KidCare staff will contact parents and ask them to pick up their child if their child cries consistently for 15 minutes or more.
12. KidCare staff will enforce behavioral guidelines for the protection of all children and employees. The guidelines cover all instances of biting, pinching, fighting, or other acts that may cause physical or emotional pain to others. We reserve the right to deny further admittance to KidCare should we feel other children or staff are unsafe.
13. Children should be fed and have used the bathroom or have had diapers changed, before check-in. If the child must use the restroom or needs a diaper change, the parent will be paged to assist the child.
14. No food, gum, or candy allowed in KidCare.
15. Children must wear shoes and/or socks while in KidCare.
16. Please leave personal items at home. VASA Fitness is not responsible for lost or damaged items.
17. It is the parent's responsibility to keep the KidCare team informed of any necessary updates to their child's records.
18. VASA Fitness will make every effort to accommodate the needs of all children. However, KidCare is not staffed or equipped to provide special care for anyone requiring individual or specialized care.
19. Member agrees and consents that VASA Fitness may use photographs, interviews, videos, and any other media featuring you and/or your children for purposes of advertising, illustration, broadcast, or distribution in any legal manner, and you waive any claim for compensation for such use.
20. Emergency Services will be contacted in the event of a medical emergency. You consent that the minor child may receive medical treatment deemed advisable by emergency service personnel and that you will be responsible for any medical expenses incurred by the minor.
21. VASA Fitness reserves the right to refuse service to anyone for any reason and reserves the right to change or modify policies and procedures at any time.

I have read and agree to abide by the KidCare agreement above. I further agree to authorize individuals identified on the Admission Agreement form as persons authorized to pick up my child(ren) in case of emergency. In addition to the above, I also agree to release, hold harmless and indemnify VASA Fitness and its employees, directors, and managers, individual partners, agents, and shareholders for any claims made by a minor or brought on behalf of a minor.
